- The same horse/rider combination cannot compete at a level if they have previously won the schooling show championship at that level
- For **INTRO LEVEL**—Riders who have competed at second level and above are not permitted to ride in the Intro Level championship class

I waive all rights to sue VADA, VADA/Nova, Inc., and/or any of their officers, directors, volunteers, employees and agents, the judges at this event, the owners or lessors of the facility where the event is held and/or any sponsor of this event for the injury to/or death of me or where applicable, the junior named below, and/or injury to property, including equines. I agree to indemnify and hold harmless the foregoing parties from and against any and all such claims of injury, death, or damage. This liability/release form is to be construed in accordance with, and to be as broad as permitting by the Equine Activity Liability/Act set forth by the Virginia Code.

The headgear and harness must be secured and properly fitted.**
